1. Conclusions of the auditor

On-site conditions of audit

Annual announced inspection has been conducted on 13.5.2019. Sample was not taken during the inspection. Traceability and balance has been controlled for organic product. Stock inventory has been checked visually. Conventional production has been seen during the inspection.

No processing info sheet or other records for each batch, with quantity produced as well as the quantity of raw materials used

Regulatory reference: V (A).6c

Description of the facts upon which the finding is based:

Production information has sent to Ecocert regularly. Efficiency of organic tahini production is identified as %90 for each batch but in processing records quantity of production loss have not seen on each production stages.

Production information has sent to Ecocert regularly. Efficiency of organic tahini production is identified as %90 for each batch but in processing records quantity of production loss have not seen on each production stages.
